The Corporate Dental Application (CDA) supports the US Army Dental Command (DENCOM) mission of providing dental care for Soldiers world-wide. CDA allows dental providers to collect, process, present and archive dental workload data, acquire digital images, and update readiness and patient scheduling data. All the data obtained by CDA and its ancillary modules is stored within the Corporate Dental System (CDS) data repository. The CDS environment includes a small collection of computing environments connected by one internal network with security segregation, but it is under the control of a single authority and security policy that includes personnel and physical security. Digital radiographic images are acquired into CDS using the Digital Enterprise Viewing and Acquisition Application (DEVAA).

The CDS repository stores the following types of PII data:

- Patient Name
- Social Security Number
- Date of Birth
- Dependent Names
- Treatment Data
- Digital Radiographic Images

(2) Briefly describe the privacy risks associated with the PII collected and how these risks are addressed to safeguard privacy.

CDA presents only a minimal risk to privacy. Through the use of encryption technologies and role-based access controls, access to data is limited to system users on a need-to-know basis. Data interconnections to and from other systems are protected by encrypting the data traffic.



1. AUTHORITY FOR COLLECTION OF INFORMATION INCLUDING SOCIAL SECURITY NUMBER (SSN)

2. PRINCIPAL PURPOSES FOR WHICH INFORMATION IS INTENDED TO BE USED
